WHEREAS, The University of Central Oklahoma Student Association has the responsibility of allocating Sponsorship funding and annual appropriations to the student organizations; and

WHEREAS, The UCOSA Ways and Means committee has reviewed applications of need submitted by UCO student associations; and

WHEREAS, The UCOSA Ways and Means committee has determined that the organizations listed below are in need of sponsorship funding or an annual operating budget; now therefore

BE IT RESOLVED BY THE UCO STUDENT ASSOCIATION

Section 1: The University of Central Oklahoma Student Association approves the appropriation of One-Time Money to:

Event Sponsorship Funding

UCO Student Ambassadors

Travel: \$7,110

Total: \$7,110.00

These funds shall be used as supplementary funds for the Student Ambassador's travel to the Student Development Institute by CIVSA conference in Spring '22 .

UCO Student School Psychology Association

Travel: \$350.00

Total: \$350.00

These funds shall be used as supplementary funds for the Student School Psychology Association's registration and other needs to their conference in Boston Massachusetts.

UCO Alpha Psi Omega

Programming: \$2,950

Food: \$50

Total: \$3,000.00

These funds shall be used as supplementary funds for Alpha Psi Omega's programming and food for their events in the Fall '21 and the Spring '22 production.

UCO Muslim Student Association

Programming: \$800

Food: \$700

Total: \$1,500.00

These funds shall be used as supplementary funds for the Muslim Student Association's programming and food for their meetings and events throughout the Fall '21 and Spring '22 semester.

UCO Student Academy of Forensic Science

Travel: \$5,800.00

Total: \$5,800.00

These funds shall be used as supplementary funds for the Student Academy of Forensic Science's travel to the American Academy of Forensic Sciences Conference.

Section 2: Specific Events Appropriations as listed in Section 1 of this resolution shall only be used for specific events as described and approved by the UCOSA Ways and Means Committee.
